* Vendor fee is \$150 (FTAA will provide 10 X 10 tent, 2 tables, and two chairs, 2 fabric table cloths. A deposit of \$25/ table cloth will be required to be refunded upon return of the table cloths)

* The fee for an additional table request is \$25. Maximum number of tables allowed in each tent is 3. Additional table request must be submitted to FTAA, latest by March 11th, 2016

Vendor agrees to the following:

1. Application deadline: On or before March 11, 2016.
2. Vendor fee is 100% refundable ONLY if Vendor is not approved by FTAA. Otherwise, it is non-refundable
3. Vendor must submit a completed and signed application and a check written out to FTAA and, send it to the address above by March 11, 2016. Vendor is considered approved unless Vendor is notified by FTAA before the festival. FTAA reserves the right to reject Vendor application, to prohibit or stop any Vendor displaying, selling or distributing any merchandise or material that is considered objectionable by FTAA or City of Hollywood. FTAA reserves the right to make this decision at any time before and/or during the Festival
4. Spaces will be allocated based on application and check received dates. Earlier vendor submits its application and send his/her payment, their tent location will be closer to the stage.
5. Non-food vendors cannot sell any food or drink items that are consumable at the Festival. Any vendor who wants to sell food or drink must carry restaurant license and have a general liability insurance of \$ one million. Vendor to have proper license, permit and insurance to sell its merchandise on the day of the activity, in the city/county the activity is held.
6. Vendor to set up its stand and be ready to display, sell or distribute its merchandise before 10:00 am. on the Festival day.
7. Vendor can not bring its own tables.
8. Vendor must have table cloths provided by festival officials on each table.
9. Vendor to keep vendor stand clean and presentable throughout the Festival day.
10. Vendor to provide all necessary equipment to run its operation on the day of Festival.
11. Vendor to provide all necessary supplies to operate its business on the day of Festival
12. Vendor to clean up its space after the event and leave its space in clean condition. Vendor is responsible to secure the goods displayed. FTAA shall not be responsible for merchandise/material left at the Festival grounds
